Dear Sisters,

The time has come to review our P.E.O. Constitution and Provincial Bylaws. Your Provincial Amendments & Recommendations Committee asks that Local Chapters, the Executive Board, and members of Standing Committees thoughtfully discuss the Constitution and Provincial Bylaws and prepare amendments for consideration at the 2018 Convention on May 4th and 5th, in Winnipeg, Manitoba.

Provincial Bylaws can be found in the Blue Section of the Proceedings Binder and on the MB-NWON website.

Please note that there are three methods of amending Bylaws and Standing Rules:

1. To INSERT or ADD words or paragraphs.
2. To STRIKE OUT words or paragraphs.
3. To STRIKE OUT and INSERT words or paragraphs.

When submitting, state the page number, article, section and line of the change or insertion. State the change and write out the article as you wish it to read, and include an explanation. The explanation does NOT give arguments. It should only describe the actual change that would occur upon the adoption of the proposed amendment. The explanation should be logical and have clear meaning.
